SECTION 1 IDENTIFICATION OF THE SUBSTANCE/MIXTURE AND OF THE COMPANY

SECTION 2 HAZARDS IDENTIFICATION

2.1 Classification under GB CLP: Aquatic Chronic 3 — H412 Harmful to aquatic life with long lasting effects.

2.3 Other hazards: Spilled crystals may create a slip hazard. Product is decorative and must not be ingested. Contains fragrance sensitizers below the threshold for classification as a skin sensitizer.

SECTION 3 COMPOSITION/INFORMATION ON INGREDIENTS

3.2 Mixtures: Sodium chloride crystals containing a proprietary fragrance blend. Reportable component ranges are calculated from the controlled internal batch record and supplier SDS; upper bounds are used conservatively.

SECTION 4 FIRST-AID MEASURES

Route	First-aid measure
Inhalation	Move to fresh air if fragrance vapour or dust causes discomfort. Seek medical advice if symptoms persist.
Skin contact	Wash with soap and water. Remove contaminated clothing. Seek medical advice if irritation or rash develops.
Eye contact	Rinse cautiously with clean water for several minutes. Remove contact lenses if easy to do. Seek medical advice if irritation persists.
Ingestion	Rinse mouth. Do not induce vomiting. Contact NHS 111 or a doctor if unwell; in an emergency call 999.
Most important symptoms	Possible irritation, nausea after ingestion, or allergic skin reaction in susceptible persons.

SECTION 5 FIREFIGHTING MEASURES

- Suitable media: use water spray, dry powder, foam or carbon dioxide appropriate to the surrounding fire.
- The salt is not combustible; the small fragrance fraction may decompose in a fire and produce irritating smoke, carbon oxides and other organic decomposition products.
- Firefighters should wear self-contained breathing apparatus and protective clothing where required.

SECTION 6 ACCIDENTAL RELEASE MEASURES

- Avoid prolonged skin contact and keep material out of drains, surface water and soil.
- Sweep or vacuum carefully into a labelled container. Avoid generating dust. Wash the affected surface to remove fragrance residue and slip risk.
- Dispose of recovered material in accordance with Section 13.

SECTION 7 HANDLING AND STORAGE

- Handle with clean, dry utensils. Avoid eye contact, ingestion and prolonged skin contact. Do not breathe dust.
- Keep the container tightly closed, upright and dry, away from heat, direct sunlight, incompatible materials, food and animal feed.
- Keep out of reach of children and pets. Do not use as bath salts and do not heat or burn.

SECTION 8 EXPOSURE CONTROLS/PERSONAL PROTECTION

Control	Recommendation
Occupational limits	No workplace exposure limit established for the finished mixture. Observe any limits stated for individual raw materials during manufacture.
Engineering controls	Normal room ventilation is adequate for packaged consumer use. Use local ventilation if handling bulk quantities or generating dust.
Hand protection	For repeated or bulk handling, wear suitable chemical-resistant gloves (for example nitrile); select using the glove supplier's breakthrough data.
Eye protection	Safety glasses are recommended during bulk mixing or where splashing/dust is possible.

SECTION 10 STABILITY AND REACTIVITY

- Stable under recommended handling and storage conditions.
- No hazardous reaction is expected in normal use. Avoid excessive heat, direct flame, strong oxidising agents and moisture ingress.
- Thermal decomposition may generate carbon oxides and irritating organic fumes.

SECTION 11 TOXICOLOGICAL INFORMATION

Hazard class	Assessment
Acute toxicity	Not classified based on available component data at the supplied concentration.
Skin corrosion/irritation	Not classified. Prolonged contact may irritate sensitive skin.
Serious eye damage/irritation	Not classified. Mechanical irritation from salt crystals is possible.
Respiratory/skin sensitisation	Not classified as a skin sensitizer; contains sensitizing fragrance substances and may produce an allergic reaction in susceptible persons.

SECTION 12 ECOLOGICAL INFORMATION

12.1 Ecotoxicity: Classified Aquatic Chronic 3 — harmful to aquatic life with long lasting effects. Avoid release to drains, surface water or soil.

- Persistence/degradability, bioaccumulative potential and mobility: not determined for the finished mixture. Sodium chloride dissociates in water; organic fragrance components have differing environmental profiles.
- PBT/vPvB and endocrine-disrupting properties: no such conclusion is made for the mixture from the available data.
- Other adverse effects: large releases may increase salinity and introduce fragrance components to the environment.

SECTION 13 DISPOSAL CONSIDERATIONS

- Do not dispose of bulk product to drains or natural watercourses.
- Small household quantities: follow local authority waste guidance. Business waste: use an authorised waste contractor and classify the waste according to its origin and local requirements.
- Empty packaging should be recycled where accepted after removal of residual product; otherwise dispose of it in accordance with local regulations.

SECTION 15 REGULATORY INFORMATION

This SDS is prepared for supply in Great Britain with reference to the retained UK REACH and GB CLP frameworks, as amended. The supplier placing the finished mixture on the market remains responsible for ensuring the classification, packaging and label match the exact formulation and current legal requirements.

A chemical safety assessment has not been carried out for this finished mixture. Product-specific consumer safety, weights-and-measures and general product safety requirements may also apply.

SECTION 16 OTHER INFORMATION

Revision 1.0, issued 11 August 2026. First issue for the supplied finished formulation.

Primary source: current supplier safety data for the proprietary fragrance blend, issue date 19/06/2026, version 30 (03/05/2026); supported by the controlled internal formulation record. Sodium chloride carrier treated as non-hazardous.

Classification method: component calculation and GB CLP summation rules using conservative upper bounds of the concentration ranges disclosed in the supplier SDS. The finished product has not been laboratory tested for the hazards in this document.

Full statement text: H410 Very toxic to aquatic life with long lasting effects. H411 Toxic to aquatic life with long lasting effects. H412 Harmful to aquatic life with long lasting effects.
